## **General Information for Homestead Farm Schooling Shows**

- Dressage Tests Offered: USDF Intro thru Fourth Level, FEI, Musical freestyle, USEA Eventing, Western • Dressage & Gaited Dressage. Depending on the entries, Classes may be combined of split.
- Ride Times: Available 4 days prior to the show at www.homesteadhorsefarm.com or from the Entry Secretary.
- Attire: All riders must wear ASTM/SEI helmets when mounted. Jackets are not required and polo shirts are allowed. No t-shirts.
- Ribbons: 1st thru 6th place in each class. A High Score ribbon and prize will be awarded to the rider with the show's highest score and a Reserve High Score ribbon and prize will be awarded to the rider with the show's second highest score (excludes Intro, MFS, Eventing, Western & Gaited).
- All shows are run per USEF rules & guidelines.
- Arenas: Standard (20m x 60m) Dressage Arena for all regular dressage classes and Small (20m x 40m) Arena for Eventing, Western & Gaited tests as applicable and *depending on entries*. Sand footing in the competition arena and a large sand arena for warm-up. Stabling is not available.
- Water, sodas, snacks are available. Riders are invited to join us for lunch during the show's lunch break. • (Mahlon enjoys firing up the grill to serve hamburgers & hot dogs!)
- Refunds will be given in full prior to the closing date. No refunds will be given after the closing date or for no-shows. If there's a waiting list, secretary may be able to fill the slot.
- Phone and email entries will not be accepted. •
- Non-compete horses are allowed, but must be registered with the Entry Secretary in advance. There will be a \$35 fee for non-compete horses, and a current Coggins must be provided.
- Please bring your own water.
- Should rider have to leave before your Class closes, ribbons can be mailed for a \$5 fee. Let the Show ٠ Secretary know (at the ribbons & awards table).
- No dogs allowed and children must be supervised at all times.
- Please clean up after yourself and do not leave any soiled bedding on the grounds.
